Following points were discussed during the meeting.

01. LAMP3 starts on 2nd March :

Breakeven has been achieved, we need to make payment for ZOOM as Dr Sinha's license is about to expire.

02. Application by vascular surgeon in USA for admission to LAMP3 for his son in 11th grade

It was discussed at great length, and if the father submits formal application to MLSI son can be admitted on following conditions

1. Father takes responsibility of supervising the son for which he pays membership fees of Rs. 12500
2. Father joins the course at concessional fees of Rs. 5000/= as member
3. Son is not a student of medical college or law college or not eligible to become a member. As such he will get admission as per paramedical professionals and pay full fees of Rs. 10,000/=

Total amount payable by Dr Murty will be Rs. 27500/=

03. Rejection of IA in Suo Motu PIL by Bombay High Court : Next

steps: Hon'ble Chief Justice said that the bench does not want to expand scope of the suo-motu PIL. He advised to file separate PIL for the points raised by MLSI. Whether to file PIL as per advise of the High Court was discussed. It was discussed that PIL be filed and Dr Rajeev Joshi be authorized to file PIL for and on behalf of MLSI as per advice of Hon'ble Chief Justice of Bombay High Court.

04. Hurdles in Suo Motu PIL by Karnataka High Court : Language problem, Clerk not cooperating, Adv wants to be on board. Clerk promised to refund the fees. We will wait for hearing on 8th Feb before filing IA.

05. Finalization of order for online application for membership and certificates online application for LAMP and certificates to be done in view of the need of such interface for LAMP and membership certificates.

06. MMC issues : Dr Joshi described that MMC is still debating whether to inspect societies or to refund money.
